Based on the article 20 of the Law on the Institutions of Higher Education ("Narodne novine" 59/96 – revised text 14/00, 67/00, 94/00, 129/00) and article 217, paragraph I of the Law on General Administrative Proceedings ("Narodne novine" 53/91) the Ministry of Science and Technology is issuing a

### OPERATING LICENSE

1. **The Zagreb School of Economics and Management – accredited college** (further referred to as the School), with headquarters in **Zagreb, Masarykova 24/1** is being issued an operating license
2. The activities of the School are:
  - development and realization of professional undergraduate and graduate programs in Economics and Management;
  - development and realization of programs of executive (continuing) education;
  - organization and holding of professional conferences;
  - offering consulting services to third parties;
  - publishing activity

The School is responsible for the execution of the educational curriculum.

3. The recording of the School into the registry of higher education institutions will be carried out by the Ministry of Science and Technology, according to regulations.
4. The School may begin operations immediately following the registration into the court registrar.

#### Explanation

The proposer of the Zagreb School of Economics and Management – a college open to the public, submitted a request for the issuing of a precursory approval for the founding of a college to the Ministry of Science and Technology on March 12, 2002.

Based on the decision of the National Council for Higher Education, reached on October 26, 1995, the Ministry of Science and Technology issued precursory approval for the founding of the School on March 25, 2002.

One of the founding proposers, the trading company Mate d.o.o. from Zagreb, Masarykova 24, obtained a positive opinion of the educational curriculum for a program of study in Economics, and gave the proposer all the rights of the approved program of study in Economic, based on the decision made on February 26, 2002.

Based on the positive opinion of the National Council of Higher Education the decision was reached according to the enacting terms.

This operating license is final in administrative proceedings.

#### Instructions on legal recourse:

This operating license cannot be appealed, but an administrative litigation can be started against it within the first 30 days of its reception.
